PET GUARANTEE

This animal must be purebred, registrable with AKC and be free of all disqualifying faults for its particular breed at the time of sale. This dog is in no way guaranteed to win in the show ring. It is understood that with the proper care on the part of the buyer, in due time the dog should be of acceptable temperament and structure and should embody the basic standards of the breed.

Dog is purebred. Pedigree is correct and given at time of sale. Dog is registrable with AKC, unless form is withheld per written agreement .

REFUND: 100%, provided dog is returned to seller.

At option and expense of buyer, 48 hour health guarantee through examination by a veterinarian acceptable to both parties.

Seller has option to:

Either REFUND: 100%, provided dog is returned to seller, or

REPLACE, provided dog is returned to seller.

To be free from hereditary crippling defects visible by 6 months of age (Seller to initial and circle those that apply.)

B. REPLACE, providing dog is returned to seller, or

C. ADJUSTMENT:

If, in future, buyer is unable or unwilling to keep the dog for any reason, he/she agrees to contract seller for assistance in placing the dog. Dog may not be resold or placed or impounded without notifying seller first. Seller has first refusal in such cases.

Buyer agrees to use prefix "Kenlakes" in registered name of dog.
